CIRCULAR

It is for the information of all concerned that in view of spread of Covid-19 and the circumstances of continuous lockdown, the University being constrained to initiate the process for fresh engagements of the contractual faculty for the Academic Session 2020-21 shall consider re-engaging the services of the Contractual faculty already engaged by the University during the last academic session i.e 2019-20, subject to fulfilling the conditions laid out below:-

The period with effect from 1st June, 2020 to 30th June, 2020 shall be treated as break for the contractual faculty engaged during the academic session (2019-20) and no remuneration or consolidated salary shall be payable to them for this period.

The detailed information in this regard in respect of the Main as well as all the Offsite Campuses of the University regarding the faculty required to be re-engaged (Course-Wise) must reach the Deputy Registrar, Teaching Wing, latest by 15th June, 2020 through e-mail to jucreationrecruitment@gmail.com as per proforma enclosed as Annexure-I.

The said re-engagement of any such contractual faculty shall however, be done initially for a period of three months, further extendable with usual breaks as per norms and shall be subject to receipt of satisfactory feedback reports from the students/ Controlling Officers received through their respective HOD/ Director/ Rector/ Co-coordinator / Principal. The said arrangement shall however be implemented on the basis of the actual faculty requirements projected by the respective HOD/ Director/ Rector/ Coordinator and Principal, keeping in mind the allocation of adequate workload as per the UGC norms.

Further, in view of circumstances mentioned above, the advertisement for the engagement of contractual faculty for the academic session 2020-21 advertised vide advertisement No Adm/TW/C&R/20/1880 dated 10.03.2020 stands withdrawn.
