ORDER

Consequent upon order No: DCJ/PS/2021-22/166-73 dated 10.04.2021 issued by the District Magistrate, District Disaster Management Authority (DDMA), Jammu regarding declaration of area in and around University of Jammu as Micro Containment Zone, the following is notified for the information of all concerned: -

- All the offline activities like teaching classes, research work, Offices in the University Campus shall remain suspended till further orders. However, classes of all the semesters, including research work shall be held online till further orders, as an interim safety measure. The official work shall also be carried on through home and through online mode, wherever feasible.
- All the students/scholars currently residing in the hostels shall accordingly be assisted in vacating the hostel rooms in liaison with the concerned UT authorities after following the Govt prescribed procedure/guidelines.
- 3. The Dhanvantri Library, Auditoriums, University Guest House, Cafeteria etc. shall also remain closed till further orders as an interim safety measure.
- Wherever the postponement of M.Phil/Ph.D Viva Voce examinations is unavoidable, same may be conducted online.
- All the examinations stand postponed till 15th April, 2021 and further decision with regard to conduct of onwards examinations shall be notified separately.
- 6. All the above decisions shall be reviewed at appropriate time for taking further necessary action accordingly and during the intervening period, the University Health Centre shall take up vigorous sanitation drive to properly clean and disinfect all the vacated areas/hostel rooms besides continuing with the already scheduled RAT Camps.
- Dr. Bharat Bhushan and Dr. Shabana Azmi. Medical Officers, University of Jamm and Chief Security Officer may be contacted in case of any emergent need.
