They can complete the said work from their respective work places (Department/Sections).

Needless to mention here that it is an important time bound exercise which need to be completed by 31.01.2023, failing which the salary of such employees whose information is not uploaded may be kept withheld for want of the requisite information on CPIS Portal. All these officials can communicate their problems (if any) in the Whatsapp group specifically constituted for the said purpose to keep track of the daily progress made in this regard and for having necessary action accordingly.
