Subject: Adoption of J&K Rehabilitation Assistance Scheme notified vide S.O. 429 dated 06.09.2022

In pursuance of the approval of the Hon'ble Chancellor and in anticipation of the approval of the University Council, the Vice Chancellor is pleased to authorize adoption of J&K Rehabilitation Assistance Scheme notified vide S.O. 429 dated 06.09.2022 in the University of Jammu in totality, along with amendments issued by the Government from time to time as well as the modifications given below:-

- (a) Vice-Chancellor, University of Jammu shall be competent authority to make compassionate appointments as per Rule 3(b) of S.O. 429.
- (b) Monetary compensation shall be paid out of Rehabilitation/any other appropriate Budget Head as approved by the Govt. of J&K as per rule 5(B) of S.O. 429.
- (c) The Committee to examine/scrutinize applications for support for self employment to dependents of deceased employees as per the terms & conditions of S.O. 429 dated 06.09.2022 may be constituted under its rule 5(C), as given below :-
 - (i) CEO, UoJSPV - **Convener**
 - (ii) Director, SIIEDC
 - (iii) One Teacher not below the rank of Professor to be nominated by the Hon'ble Vice Chancellor
(Prof. Pankaj Srivastava, Director, DD&OE nominated vide order No. Estab/24/21104-12 dated 11.01.2024)
 - (iv) Assistant Registrar (Estab.) - **Member Secretary**
- (d) University Council shall be the authority to decide exemptions and relaxations as per rule 6 of S.O. 429.
- (e) Deputy Registrar (TW) (for Teaching employees) / Assistant Registrar (Estab) (for Non-Teaching employees) shall be the Welfare Officer respectively.
- (f) Committee for scrutiny of applications for compassionate appointments/monetary compensation may be constituted as per rule 12(ix) as given below:-
 - 1 Registrar - **Convener**
 - 2 One Professor to be nominated by the Hon'ble Vice Chancellor
(Prof. Virender Koundal nominated vide Order No. Estab/24/21113-21 dated 10.01.2024)
 - 3 Joint Registrar (Finance)
 - 4 Chief Accounts Officer
 - 5 Assistant Registrar (Estab.) - **Member Secretary**
- (g) Vice-Chancellor shall be the Competent Authority for interpretation of rules.
