

67 candidates share top rank in NEET-UG

New Delhi: Sixty-seven candidates have bagged the top rank in medical entrance

exam Neet-UG, a majority of them from Rajasthan, the National Testing Agency

announced on Tuesday. The top rankers in the

National Eligibility cum Entrance Test (Neet) also include 14 girls, the

agency said. It said the 56.4 per cent of the candidates have qualified the exam, which was conducted on

May 5 at centres across the country and also abroad. "Sixty-seven candidates scored the same 99.997129 percentile score, therefore,

they shared the all India rank one. The merit list will be prepared using a tiebreaking formula with those

getting higher marks or per-centile score in Biology will be given preference followed by Chemistry and Physics," a senior NTA official said. "Subsequently, candidates with less propor-

tion of the number of attempted incorrect answers and correct answers in all the subjects in the test, or Biology, followed by Chemistry and Physics, will be given preference," the official added. Of these 67 candidates, maximum 11 are from Rajasthan, followed by

seven from Maharashtra. A record 24.06 lakh candidates had registered for National Eligibility cum Entrance Test this year. passing percentage is almost the same as last year at 56.2 per cent. Among those who qualified, 5,47,0-36 are male, 7,69,222 are female and 10 are transgender, NTA said. - PTI

Campus hires: companies up against growing attrition rate

eloitte India's latest campus-workforce trends 2024 indicates a shift towards hiring based on skills and a greater focus on gender-diverse talent recruitment and a need to ink in retention strategies that would ensure campus hires are in a long innings with the company. The survey encompasses data from over 190 organisations and 500 campuses.


Focus on specific skills

Organisations are pivoting to specific skills/ competency clusters within the educational stream while selecting their talent. For example, AI/ ML in engineering, social selling in management and computational biology in pharma are the most indemand skill segments. Complementing this trend, expectations from campus students are pivoting to management consulting roles for MBA specialisation and data scientist for technology talent.

Retention reboot needed

Attrition remains a significant challenge, especially among MBA graduates. Overall, one-year and twoyear attrition rates for top-tier campuses are 21 percent, 26 percent and 28 percent, in a pan-India assessment. These rates drop, only slightly, where tier-2 and tier-3 campuses are concerned. This trend underscores the need for innovative retention strategies. To combat this challenge, leading organisations are implementing flexible work arrangements, performancebased incentives and targeted career development programmes.

Workplace diversity



The report underscores significant progress in workplace gender equality and diversity hiring. Female campus hiring increased in FY24 compared with that in FY23. However, the availability of genderdiverse talent remains a challenge, especially in the engineering stream. Rise in various initiatives also supports the hiring of differently-abled individuals and those with diverse gender identities. Targets for hiring differently-abled employees increased from 5 percent in FY23 to 9 percent in FY24, while LGBTQIA+ hiring targets surged from 8 percent to 20 percent.

Location preferences

The survey reveals distinct location

preferences for different disciplines. For engineering graduates, Bangalore, Hyderabad and Chennai emerge as the top destinations, likely due to their thriving tech ecosystems, prestigious universities and robust job markets. In contrast, for students pursuing management degrees, the top three preferred locations are Bangalore, Delhi and Mumbai. Bangalore's reputation as an IT and start-up hub likely makes it attractive for management students seeking opportunities in diverse industries.

Salary trends

For the first time in 5 years, 2024 projected salaries for management students (viz. MBA) are experienc-

ing a drop of 5 percent to 10 percent across tiers.

Notably, the expectation of salary by campus students is also experiencing a similar decline. Variable pay increased by 250 basis points over the past year, indicating a shift towards higher performance orientation by employers.

Internship intake

Internship intake by organisations reduced by 10 percent on an average, indicating declining uptake. Similarly, pre-placement offers (PPOs) have experienced an annual drop of 26 percent.

Complementing it, campus hiring budgets saw a 33 percent drop in the past year.

Rajasthan village girls struggle for sports opportunities Girls in rural India face challenges accessing sports and education due to limited spaces, family restrictions and gender disparity

▼ n our village, there is no field for girls to play on. ▲The entire village has only one school with a usable field, but it's dominated by boys, forcing us to practice in a corner, said 16vear-old Sonu from Ghadsisar village in Churu district in Rajasthan, who practices kho-kho daily with

17-year-old Aarti, who practices kho-kho with Sonu, said, "Our team has only traveled once Sardarshahar tehsil and once to Foga village to participate in the game. After that, we haven't gone anywhere. We don't get the chance because our performance isn't good enough. How can we per-

form well without proper practice opportunities? Having a field for practice is essential, but we don't have one." Girls do not receive support from their families to go outside the village to

practice. Ghadsisar village, located about 254 km from Jaipur in Churu district, has a population of around 3,900. Within this small popula-

tion, there is a significant

disparity in literacy rates between men (62.73%) and women (38.8%). This reflects the discrimination that girls face in terms of education. Within this smaller group, girls who are challenging the social norms, are further discriminated against due to a lack of a dedicated sports field for girls. Consequently, their practice sessions are disrupted, negatively affecting

their performance. "This village has about 800 houses. The girls who study at the village school still get practice opportunities during school days, but where should the girls who no longer study here go for practice?" said Kanta, another young girl from the village. "The boys can play



anywhere or in fields in other villages, but our families don't allow us to go far from home for practice. Therefore, our village needs a dedicated field for girls to

play," she added. With years of negotiations, they did manage a corner space in the field but even that becomes unavailable during vacations. "The boys

often climb over the school wall to play on the field, but we girls can't do that,"

informed Kanta. Regarding this issue, the village sarpanch, Manoj Kumar, acknowledged that there is no separate field for girls in the village, which causes difficulties for them in practice. He mentioned that the gram panchayat had submitted a proposal to the tehsil headquarters, but the tehsil authorities indicated that while there is vacant land in Ghadsisar, it belongs to the johad paytan (water reservoir) and the mining department. Allocating this land for a sports field is beyond the tehsil's jurisdic-

Understanding the situation, the panchayat selected a different site and submitted a new proposal to the tehsil. However, due to the code of conduct imposed for the Lok Sabha elections, no action has been taken. The panchayat will make another attempt after the election process is completed to ensure a sports field is avail-

able for the girls. Social worker Heera Sharma emphasized the importance of sports for all children, stating, "Whether it's a boy or a girl, playing sports is crucial for physical and mental development. It not only keeps the body healthy but also enhances mental well-being. Denying girls the opportunity to play would be unjust. Playing sports boosts girls' confidence, allowing them to run freely on the field and contributing significantly to their physical development." She added, "Sports are excellent for fitness and can also provide a career path, with athletes bringing honor to the country. This is why the government is promoting

sports and athletes through

initiatives like 'Khelo India.'

Many girls from rural areas

have emerged to represent India at district, state,

Olympic Commonwealth games, winning medals for the country." This year, at the sixth Khelo India Youth Games held in Tamil Nadu, athletes from Rajasthan delivered outstanding performances across various events, earning the state a place in the top 5. Both girls and boys excelled. Yet despite these successes, many rural areas in the country continue to deprive girls of the chance to participate in sports, even though access to sports fields is essential for all adoles-

Delhi High Court orders re-admission of DU law student barred for attendance shortage

The Delhi High Court has ordered the re-admission of a Delhi University (DU) law student, previously barred from continuing his course due to attendance shortages stemming from a medical condition

The student, who suffers from psoriasis, had fallen short of the university's mandatory attendance requirements and was instructed to reapply for admission by retaking the entrance exam.

Challenging this decision, he filed a writ petition, which was initially dismissed by a single-judge bench.

However, a division bench of Justices Rajiv Shakdher and Amit Bansal overturned this decision, saying that the university failed to differen-



tiate between students who miss classes for genuine reasons and those who do so without valid explanations.

"The University has adopted an approach best described as one size fits all," the court remarked, criticising its uniform policy towards all students irrespective of their reasons for attendance shortfalls

It also noted the Bar Council of India's (BCI) stance, which supported the readmission of students who miss classes due to legiti-

mate medical reasons.

The BCI's affidavit said that once a student is admitted to pursue legal education, their admission should not be cancelled if they fail to meet attendance requirements for genuine reasons.

In its defence, the university argued that psoriasis, a non-contagious disease, should not have prevented the student from attending classes

However, the court recognised the seriousness of the condition, noting its poten-

tial to cause significant discomfort and affect vital organs.

"Psoriasis is a skin disease which often takes grotesque forms, causing deep embarrassment and discomfort. Itching is a peculiar feature of the disease, leading to extreme discomfort," it stated, referencing the student's medical documentation and photographs submitted as evidence.

It further criticised the university for trivialising the student's condition by questioning his choice of a homoeopathic doctor and showing disbelief in his illness claim. The judges took judicial notice of the effectiveness of homoeopathic treatments for certain skin diseases, noting the university's failure to investigate the student's claims properly.

Additionally, it rejected the university's argument

that it lacked the power to grant re-admission to a student detained in the first term.

Citing relevant provisions of the University Ordinance, the court clarified that the university could re-admit students who had genuine reasons for their absence, including illness. The relevant provision. Article 5(b) to Ordinance IV. states: "A student of the University who was not allowed to appear in the examinations due to shortage of attendance will be readmitted to the class he studied last in his College/Department, within the prescribed period of registration." Based on these findings, the court allowed the student's appeal, quashed the single-judge decision, and directed Delhi University to re-admit the student for the upcoming academic year (2024-2027 batch). भारतीय शिक्षा प्रणाली को दुरुस्त करने में सतीश चंद्र ने दिया था योगदान

जागरण संवाददाता, नई दिल्ली: इंदिरा गांधी राष्ट्रीय मुक्त विश्वविद्यालय (इग्नू) ने जुलाई 2024 सत्र से दो नए डिप्लोमा कोर्स शुरू किए हैं। इसमें कृषि लागत प्रबंधन में डिप्लोमा और मानसिक स्वास्थ्य में स्नातकोत्तर डिप्लोमा कोर्स पढ़ाएं जाएंगे। इग्नू ने कृषि लागत प्रबंधन के लिए भारतीय लागत लेखाकार संस्थान (आइसीएमएआइ) के साथ साझेदारी की है। इस कोर्स का उद्देश्य छात्रों को प्रभावी कृषि लागत प्रबंधन कृषि उत्पादकता में वृद्धि के लिए आवश्यक कौशल से लैस करना है।

इस कोर्स में कृषि प्रबंधन से लेकर उद्यमिता और संगठनात्मक नेतृत्व तक की भूमिकाओं को व्यापक तरीके से पढ़ाया जाएगा। पाठ्यक्रम विशेष रूप से शहरी और ग्रामीण दोनों युवाओं को लिक्षत करने के लिए तैयार किया गया है। पाठ्यक्रम में कृषि-आपूर्ति शृंखला प्रबंधन, भूमि उपयोग और जल प्रबंधन जैसे महत्वपूर्ण विषय शामिल हैं। इस पाठ्यक्रम के लिए वो ही उम्मीदवार आवेदन कर सकते हैं जिन्होंने 12वीं की परीक्षा उत्तीर्ण की हैं। पाठ्यक्रम की अवधि एक से तीन वर्ष तक है। इसके साथ ही इग्नू ने मानसिक स्वास्थ्य में पीजी डिप्लोमा कोर्स शुरू किया है। मानसिक स्वास्थ्य में पीजी डिप्लोमा कोर्स स्कूल आफ सोशल साइंस के तहत पढ़ाया जाएगा। इससे उम्मीदवार मानसिक स्वास्थ्य के क्षेत्र में एक मजबूत आधार प्राप्त कर सकेंगे। इग्नू के पात्रता मानदंड के अनुसार इस कोर्स में आवेदन करने के लिए उम्मीदवार के पास मनोविज्ञान, निर्संग, सामाजिक कार्य, एलोपैथी, यूनानी, सिद्ध, होम्योपैथी या प्राकृतिक चिकित्सा में मास्टर डिग्री होनी चाहिए।
