PG ADMISSION NOTIFICATION – 13

(2nd ROUND OF MID ENTRY ADMISSION CUET & NON-CUET- FOR VACANT SEATS ONLY)

It is for the information of all concerned that after completion of four rounds of allocation of seats the University announces **2nd Round of MID ENTRY ADMISSION (for vacant seats only)** for the Candidates who failed to apply for PG Admission CSAS-PG-2024 (*Common Seat Allocation System-PG-2024*), within the stipulated time, and have passed the qualifying Bachelor's Degree Examination (Honours or General or a qualifying examination of a professional degree of not less than 3 years duration or any other examination recognised as equivalent thereof), from a recognised university/institution with at-least 50% of the aggregate marks (45% for the SC/ST candidates).

THIS ROUND IS OPENED ONLY FOR THE VACANT SEATS FOR BOTH CUET & NON-CUET- APPLICANTS.

The applicants can participate in the 2nd Round of MID-ENTRY WINDOW, by paying a **Non-Refundable MID-ENTRY FEE of Rs. 700/-** (Rupees Seven Hundred Only), as per schedule given below:

5.	Candidates to " FREEZE " the Allocated Department/ Campus/ College from his/her Account	13-07-2024 to 16-07-2024 (Upto 04:00 pm)
6.	PHYSICAL VERIFICATION of the Original Documents and ADMISSION of the applicants who were allotted any Programme/ Campus/ College in the 5 th Allocation of Seats	15-07-2024 & 16-07-2024 (9:30 am to 5:00 pm)
7.	LAST Dates for Online payment of ADMISSION FEE by the Candidates	15-07-2024 to 17-07-2024 (Till 12:00 Midnight)

Following GUIDELINES will be applicable for the ALLOCATION of Vacant Seats under SECOND Round of Mid Entry Admission opened for CUET & Non-CUET:

- The candidates who have already admitted in any of the programmes in the previous rounds of allocation shall **not be eligible** for the 2nd Round of the Mid-Entry Admission.
- All the candidates who have already filled online admission form and not admitted in any of the previous allocated lists **need not to apply afresh and shall also be considered for 2nd Round of Mid Entry.** However, these applicants have to **OPT / FILL FRESH PREFERENCES** for the vacant seats. Preferences given for the earlier allocation round shall become **NULL & VOID**.
- The CUET-PG-2024 applicants will be given first preference for admission and the Non-CUET applicants will be considered under second preference.**
- CUET-PG-2024 applicants will be allocated seats on the basis of the CUET-PG-2024 score whereas the Non-CUET applicants will be allocated seats on the basis of the academic merit of their qualifying examination.

- e. **A candidate who applies in the 2nd Round of Mid-Entry will not hold any right to claim the seats allocated to candidates who had applied to CSAS-PG-2024 during the initial Application Phases. Allocation of seats to such candidates may be considered subject to fulfillment of eligibility criteria, availability of seats, and other CSAS-PG-2024 rules.**
- f. Once the seat has been allocated to the candidate, it will be mandatory for him/her to take admission on the allocated seat. Failure to accept (FREEZE) the allocated seat will forfeit the candidate's right to seek admission to the course. The seat allocated in mid entry allocation round will be final and will not be upgraded in any subsequent allocation round.
- g. Mid-Entry will only be considered after successful remittance of the Mid-Entry fee. Merely applying through Mid-Entry does not guarantee a seat.
- f) In the Mid Entry, the allocation will be done on the basis of following Criteria.**

- g) **Once the candidates are provisionally admitted in the Final Allocation, the admitted candidates will be required to Visit the Allocated Department/ Nodal Department for physical verification of documents at the department along with their original documents.**
- h) The candidates will be considered admitted only after successful remittance of the requisite admission /Self Finance fees.
