**Subject: UNIVERSITY REGULATIONS**


It is notified that the 83<sup>rd</sup> meeting of the University Council held on 24<sup>th</sup> October, 2017 at Raj Bhavan, Srinagar approved the following Regulations:-

- (i) Amendments in the existing 'Rules for the Use of the Dhanvantri Library, 2006' as given in Annexure-I shall be incorporated in Chapter XIV-A, Vol-I of the University Calendar, 2010 (Resolution No. 83.14).
- (ii) Incorporation of the following regulation w.r.t. setting of alternative question papers for failure candidates (including compartment and exemption cases) in the University of Jammu in Chapter LXXIV, Regulations (2), Vol-II of the University Calendar, 2010 (Resolution No. 83.15)
  1. If the change in the syllabi and courses of study is less than 25%, no alternative question papers be set.
  2. If the change is 25% and above but below 50%, alternative question papers be set for one year.
  3. If the change is 50% and above or whole scheme is changed alternative question papers be set for two years.
  4. The percentage of change in the syllabus will be decided by the concerned Board of Studies. However, the Dean Academic Affairs in consultation with the Convener of the concerned Board may, for the purpose of expediency, decide the percentage of change in the new syllabus.
- (iii) Amendment in the Regulations pertaining to the constitution of Planning Board of University of Jammu as detailed below:
