**Dear Candidate,**

Congratulations on being shortlisted for the remaining (12) twelve seats in the Self Finance at the Law School, University of Jammu. We appreciate your interest in pursuing legal education with us.

Please take note of the following guidelines for the upcoming counseling and seat allotment process:

- **Special Round Selection:** Seats will be offered to candidates who were selected in the special round in the order of merit.
- **Waiting List Consideration:** Any seats falling vacant from the selected candidates will be allocated to candidates on the wait list based strictly on their merit as determined by the Common University Entrance Test (CUET) scores. The waiting list shall be invoked, only if any seat(s) left vacant out of the selected candidates.
- **Attendance at Counseling:** To secure a seat, it is mandatory for candidates to mark the attendance and then attend the counseling session on the scheduled date and time. Please mark your attendance during the reporting time. The Candidate who has not marked the attendance during reporting time will not will allowed to attend the counselling.
- **Attendance Requirement:** Candidates who fail to be present during the scheduled counseling date risk forfeiting their candidature.
- **Self-Finance Fee:** Aspiring candidates seeking admission to the **Self-Finance** Seat must submit the fee of **INR 1,81,500 (Self-financing Fee) + INR 45,081 (totaling INR 2,26,581)** passed out for *JK Board*, or **INR 1,81,500 + INR 46,051 (totaling INR 2,27,551)** for *other than JK Board* within the stipulated timeframe. *\*Fee may vary and can be confirmed at the time of counselling.*
