**Terms and Conditions for the supply of equipment/s for the Human Performance Laboratory**

1. The Tender should be sealed in two envelopes, Envelope-A (Financial Bid) containing rates of the item/s (inclusive of all taxes) and Envelope-B (Technical Bid) containing other related documents such as registration certificate with the concerned State/Center Govt. authorities, GST number, item/s manual/s (in any) etc.
2. Only sealed tender shall be accepted and unsealed tender shall be rejected out rightly.
3. The successful tenderer shall have to enter into an agreement with the University of Jammu prior to issuance of supply order.
4. The undersigned reserved the right to accept or reject any tender without assigning any reason thereof.
5. The income tax, service tax, or any other tax levied by the Government by time to time shall be applicable and deducted at source.
6. The rates shall be valid up to 31-03-2021 and if required can be extended with the consent of both the parties, after the approval of the competent authorities.
7. The complete supply should be made within 45 days from the date of issuance of supply order.
8. In case, the supplier fails to supply the required quantity of items within the stipulated time, CDR/FDR deposited by the firm shall be forfeited by the Directorate.
9. In case of any dispute arising out of the contract, the same shall be referred to the Arbitrator (Vice-Chancellor of the University) whose decision in the matter shall be final and binding on both the parities
